- o #16 tee large cottonwood went down; has been removed and cleaned up.
- Need to look at the 4 or 5 cottonwoods on the #14 tees need to consider cutting those down.

## <u>HOUSE – Restaurant, Pro-Shop & Social</u> (L. Vance / Unzicker / Duncan / Fulton / Heitz / Steach):

- o Restaurant & Clubhouse:
  - Finalized the menu changes.
- o Pro-shop:
  - February had 621 rounds
- o Social:
  - New webpage design almost done; will have a separate page for stockholders with ID & password required.

## PLANNING, PERSONNEL & MEMBERSHIP (L. Vance / Snider):

- o Will finalize membership numbers after the Open House in March.
- o Renewal of blue chip policy is due in May; reviewing options.
- Updating the long range plans.

#### GENERAL MANAGER REPORT (L. Vance):

- Electric costs are continuing to rise; L. Vance did some research on different light bulb options and will plan to use LEDs throughout the clubhouse. Also looking variable speed pumps – may need to wait until a new pump house is needed in about 5 years.
- All servers/bartenders that are 18+ will need to take the online BASSET certification class (alcohol seller-server training).
- Working on filling open staff positions.
