CALL TO ORDER:

The regular board meeting of the Board of Directors of the El Paso Golf Club, Inc. was held on the above date at the clubhouse. The meeting came to order at 6:30 pm. SECRETARY'S REPORT (Berry):

The board reviewed the minutes of the previous board meeting – the minutes were approved on a motion by Heitz and seconded by Snider.

TREASURER'S REPORT (Schulkins):

Schulkins reported the following – *all figures are YTD as of August 31, 2017 and compared to 2016*:

- \circ Golf Course:
 - Total income is down from 2016 by \$13,008.
 - Dues are down \$8,617.
 - Cart rentals are up \$1,712 and cart cards sales are up \$1,310.
 - Green fees are down \$11,023.
 - Shed rent is down \$1,025 and trail fees are down \$1,150.
 - Initiation fees are down \$300.
 - Project costs are up \$25,644.
 - Payroll is down \$2,188.
 - Net income is down \$79,649. (2016 was up \$34,326 over 2015)
- Pro-shop:
 - Total income is up \$1,794.
 - Cost of goods sold is down \$3,673.
 - Payroll is down \$22,441.
 - Net Income is up \$25,480. (2016 was down \$5,980 over 2015)
- o Restaurant:
 - Total income is up by \$3,549.
 - Beer sales are down \$1,263, liquor is up \$5,876, wine is up \$500 and pop is down \$1,735.
 - Food sale are down \$780.
 - Cost of goods sold is up \$5,680.
 - Payroll is down \$7,433.
 - Net income is up \$6,648. (2016 was down \$5,225 over 2015)
- Miscellaneous:
 - Total net income down \$47,521; total net income for 2016 was up \$23,121 from 2015
 - At the end of August we had \$52,813 in the bank; at the end of August 2016 we had \$97,951.

The treasurer's report was approved on a motion by Weikel and seconded by Berry.
