# EL PASO GOLF CLUB MINUTES March 9, 2022

### CALL TO ORDER:

The regular board meeting of the Board of Directors of the El Paso Golf Club, Inc. was held on the above date at the clubhouse and via Zoom (\* = those via Zoom connection). The meeting came to order at 5:05 pm. Present were directors: Aaberg, Arends, Berry, Fulop, Heitz, Koth\*, Kridner\*, Schulkins, Strader, Weldon, and Young. No Directors were absent. Employees present: L. Vance. Guests present: Ben Wilson

### SECRETARY'S REPORT (Berry):

The board reviewed the minutes of the previous board meeting (November 2021) – the minutes were approved on a motion by Young and seconded by Aaberg.

#### TREASURER'S REPORT (Schulkins):

Schulkins reported the following – *all figures are YTD as of February 28, 2022 and compared to 2021*:

- Golf Course:
  - Total income is up \$15,591.
  - Dues are up \$12,109.
  - Trail fees are down \$1,275.
  - Shed rent is up \$2,000.
  - Building costs are up \$6,288.
  - Payroll is up \$24,658 (Includes Pro Shop).
  - Diesel is up \$6,330 (Paid earlier this year).
  - Gas is up \$7,322 (Paid earlier this year).
  - Net income is down \$27,000. (2021 Net income was up \$123,143 over 2020)
- Pro Shop:
  - The total Pro Shop loss for 2021 was \$18,875.
- o Restaurant:
  - Total income is up \$5,337.
  - Food sale are up \$4,937.
  - Cost of goods sold is up \$1,548.
  - Net income is up \$3,308. (2021 was up \$2,594 over 2020)
- o Miscellaneous:
  - Total Net Income is down \$4,817 from 2021.
  - Total Net Income for 2001 was up \$114,617 from 2020.
  - At the end of February we had \$449,088 in the bank (\$3,065 is from QOH).
    - At the end of February 2021 we had \$396,106 in the bank (\$27,945 was from QOH).

The treasurer's report was approved on a motion by Heitz and seconded by Weldon.

## The committee reports were given as follows:

GOLF COURSE - Grounds & Equipment (L. Vance / Roberts / Koth / Young):

- Grounds:
  - Cleaned sprayers. Have new program to monitor chemical applications.
  - Sharpen mowers; rebuilt cup cutter.
  - Organized shop; detailed all equipment.
  - Clean up of course overall; painted the water coolers.
  - New carts arrived could be used for 36 holes, but plan to charge after 1 round.
  - Started working on member's carts.
  - Contacted the flower folks, Kim Elder is coming back.
  - Asphalt we are first on the list to start when the weather cooperates
    - Marked all spots
    - Think it will be great when it's all done
    - Plan to do maintenance areas and address all entrances and exits to bridges

HOUSE – Restaurant, Pro-Shop & Social (L. Vance / Baker / Christensen / Schuerman / Strader / Aaberg):

- *Restaurant & Clubhouse*:
  - New back bar counter is done looks great.
  - Will need new beer coolers within the next 5 years.
  - Looking at new tables and chairs for the deck.
  - Christensen is working with the supplier to put together a recipe book to help with costs.
  - About  $\frac{1}{2}$  of the items are increasing in costs.
  - Added a slicer for the kitchen will save about \$1/pound in costs.
  - Added a dough sheeter will save about \$1.50/crust; can also make cinnamon rolls.
  - Need a 2-door freezer (~\$3,500 \$4,000)
  - Need a refrigerator for the beer for the beer cart
  - Hired a beer cart person; most servers are back; kitchen will need 10, currently have 5 people.
- Pro-shop:
  - Schuerman is getting the Pro-Shop all set up.
  - No Tour Edge; more emphasis on Callaway.
  - Employees 10-12 part-time; will need about 4 more.
- o Social:
  - QoH drawing Sunday, March 13 at the Open House.

# PLANNING, PERSONNEL & MEMBERSHIP (L. Vance / Fulop):

• Membership – all bills sent out; 15 not joining. Most likely we will be able to let all of the wait list people in this year.

# GENERAL MANAGER REPORT (L. Vance):

 $\circ$  Ordered new bag tags – will give them out at the Open House.

### OLD BUSINESS:

• Scooters and Golf Boards on course: fees based on number of bag holders. ½ cost of trail and shed fees for scooters and golf boards, if they only hold one golf bag.

#### NEW BUSINESS:

 $\circ$  Nothing new at this time.

#### **GENERAL COMMENTS:**

• Nothing additional at this time.
