

## Published in the El Paso Journal, November 1, 2023. Originally published in the El Paso Journal, November 1, 1923.

"This morning numerous members of the El Paso Golf Club were seen with axes, saws, rakes, shovels, and other working tools, all piled into automobiles and trucks and hustling down to the new grounds four miles south of town. The 60 acre tract has been used mostly as pasture land for a great many years. While there is no hazel or other brush, there are many scores of fine oak trees that need trimming up and the premises otherwise cleaned of stumps and other nonessentials to golfing and picnic grounds generally."

Seven months later, the first round of golf was played on June 5, 1924.
